**YES, THE TIME HAS FINALLY ARRIVED...No more checks to write with your scrip orders. As of the distribution of this notice, you may now authorize the scrip purchase total be drawn directly from your checking account!**

The electronic payments come with a transaction cost of \$.50 per order. This e-payment charge along with the appropriate ScripMgmt percentage (minimum per order) will be deducted from your merchant earnings.

- I/We hereby authorize** the Elgin Aquatics Association, or its designated agent, and the designated financial institution, below, to initiate automatic electronic deductions from the account identified in the amount of my fundraising team transactions.
- I/We understand** that termination of payment authorization can be executed by oral or written notice to the financial institution at any time up to 5 business days prior to the scheduled withdrawal of funds allowed by this authorization.
- I/We understand** that my monthly bank statement will typically show the amount and date of payment withdrawal and that I/we are responsible for ensuring that the account designated below has sufficient funds to cover the automatic withdrawal.
- I/We understand** that if a NSF condition is encountered with the processing of this withdrawal, there will be an additional \$5.00 charge to the account for return of the transaction. Additionally, at Elgin Aquatics Association discretion, the privilege of electronic account deductions could be discontinued.
